Viz:

1 At the end of subtitle B of title I, add the following:

2 **SEC. 1222. MOTHERS' ROOMS AT AIRPORTS.**

3 (a) LACTATION AREA DEFINED.—Section 47102, as
4 amended by section 1216 of this Act, is further amend-
5 ed—

6 (1) by redesignating paragraphs (12) through
7 (31) as paragraphs (13) through (32), respectively;
8 and

9 (2) by inserting after paragraph (11) the fol-
10 lowing:

11 “(12) ‘lactation area’ means a room or other lo-
12 cation in a commercial service airport that—

1 “(A) provides a location for members of
2 the public to express breast milk that is shield-
3 ed from view and free from intrusion from the
4 public;

5 “(B) has a door that can be locked;

6 “(C) includes a place to sit, a table or
7 other flat surface, and an electrical outlet;

8 “(D) is readily accessible to and usable by
9 individuals with disabilities, including individ-
10 uals who use wheelchairs; and

11 “(E) is not located in a restroom.”.

12 (b) PROJECT GRANTS WRITTEN ASSURANCES FOR
13 LARGE AND MEDIUM HUB AIRPORTS.—

14 (1) IN GENERAL.—Section 47107(a) is amend-
15 ed—

16 (A) in paragraph (20), by striking “and”
17 at the end;

18 (B) in paragraph (21), by striking the pe-
19 riod at the end and inserting “; and”; and

20 (C) by adding at the end the following:

21 “(22) with respect to a medium or large hub
22 airport, the airport owner or operator will maintain
23 a lactation area in each passenger terminal building
24 of the airport in the sterile area (as defined in sec-

1 tion 1540.5 of title 49, Code of Federal Regulations)
2 of the building.”.

3 (2) APPLICABILITY.—

4 (A) IN GENERAL.—The amendment made
5 by paragraph (1) shall apply to a project grant
6 application submitted for a fiscal year begin-
7 ning on or after the date that is 2 years after
8 the date of the enactment of this Act.

9 (B) SPECIAL RULE.—The requirement in
10 the amendments made by paragraph (1) that a
11 lactation area be located in the sterile area of
12 a passenger terminal building shall not apply
13 with respect to a project grant application for
14 a period of time, determined by the Secretary
15 of Transportation, if the Secretary determines
16 that construction or maintenance activities
17 make it impracticable or unsafe for the lacta-
18 tion area to be located in the sterile area of the
19 building.

20 (c) TERMINAL DEVELOPMENT COSTS.—Section
21 47119(a) is amended by adding at the end the following:

22 “(3) LACTATION AREAS.—In addition to the
23 projects described in paragraph (1), the Secretary
24 may approve a project for terminal development for

1 the construction or installation of a lactation area at
2 a commercial service airport.”.

3 (d) PRE-EXISTING FACILITIES.—On application by
4 an airport sponsor, the Secretary of Transportation may
5 determine that a lactation area in existence on the date
6 of the enactment of this Act complies with the requirement
7 of paragraph (22) of section 47107(a) of title 49, United
8 States Code, as added by subsection (b), notwithstanding
9 the absence of one of the facilities or characteristics re-
10 ferred to in the definition of the term “lactation area”
11 in paragraph (12) of section 47102 of such title, as added
12 by subsection (a).
