Since the Senate's fresh start in January, our panel of twenty-four senators has worked to spur job creation through policies that strengthen our nation's competitiveness in the global marketplace. This report offers an update on what we have accomplished in the first quarter of the 114th Congress and what we will focus on in upcoming months.

The Senate passage of legislation to reform passenger rail service (S. 1626), improve highway safety (S. 1732), and address challenges in our freight transport system (S. 808) highlights the early success of bipartisan efforts undertaken this year by the committee.

Beyond our most recent efforts to help pass a multi-year transportation bill to end the need for short-term extensions, we continue to work on a broad range of oversight and legislative reforms. Our initiatives range from more effective management of ocean fisheries to space and Internet policies that are critical to our nation's economic growth and scientific innovation.

From our six active subcommittees to the full committee membership, our committee continues efforts to forge a federal government that is more accountable, transparent, and responsive to the needs of the constituents we serve.

Looking to the **WORK AHEAD**

Advancing committee-approved legislation through the U.S. Senate and House of Representatives, and ultimately to the president for enactment is a top priority. As the 114th Congress moves forward, expect the committee to focus on the following key issues:

A SECURE AND OPEN INTERNET

Federal policies and efforts to safeguard critical information have fallen behind the reality of today's digital economy. Proposals to address overregulation of the Internet, modernize the Federal Communications Commission (FCC), secure cyberspace, and define consumer rights when personal information is lost in a data breach remain a continued focus of committee efforts. In addition, oversight of efforts to secure the federal government's own networks remain a priority.

WIRELESS BROADBAND & SPECTRUM REFORMS

From telehealth medical services to the burgeoning Internet of Things (IOT), wireless broadband plays an increasingly critical role with U.S. innovation and economic growth. The federal government not only regulates and manages spectrum, which is what fuels wireless technology, but it is also a major owner of underutilized public airwaves. From oversight of spectrum auctions to promoting wireless broadband deployment, the committee will pursue policies that maximize public benefit of our airwaves as a valuable resource.

FEDERAL AVIATION ADMINISTRATION REAUTHORIZATION

The current authorization of the Federal Aviation Administration (FAA), which manages and is responsible for the safety and efficiency of our airspace, expires on September 30, 2015. The FAA and the aviation sector are struggling to implement satellite-based air traffic control, known as NextGen, and address challenges with unmanned aircraft systems. A multi-year reauthorization offers an opportunity to examine the current system and make key improvements that will benefit the traveling public. While a short-term extension is possible, the committee will focus on a long-term reauthorization.

TRANSPORTATION SECURITY ADMINISTRATION

High profile failures and warnings from government watchdogs have heightened concerns about the Transportation Security Administration's (TSA) ability to stay ahead of evolving security threats to the traveling public. On a bipartisan basis, the Commerce Committee expressed concern about the extended absence of a White House nominee to lead the agency and acted quickly to confirm a candidate after a qualified nomination was put forward. Systemic problems still plague TSA and the committee will press forward with legislative efforts to address them.

SPACE & SCIENCE

Building on Senate passage of S. 1297, the U.S. Commercial Space Launch Competitiveness Act, the committee will continue work to provide clearer focus and policy direction for commercial space and NASA's exploration efforts. Supporting science as a priority, a bipartisan working group led by Sen. Cory Gardner (R-Colo.) and Sen. Gary Peters (D-Mich.) will press ahead with efforts to introduce and advance bipartisan legislation to set federal research and development policy priorities within current budget realities.

WORK AHEAD

HIGHWAY BILL

While the Senate has approved a multi-year surface transportation bill with key freight and passenger rail (S. 1626) and safety (S. 1732) reforms put forward by the Commerce Committee, the House of Representatives has yet to pass a multi-year bill. With a current extension lasting only until the end of October, the House and Senate will have to work together to enact critical reforms.

PIPELINE SAFETY

Authorization for the Pipeline and Hazardous Materials Safety Administration (PHMSA), a component agency of the Department of Transportation, expires at the end of September. While this agency does not require an extension to avoid disruption of operations, reports have cast significant doubts about its effectiveness in protecting the public. The committee will consider needed reforms of PHMSA as part of a reauthorization this year.

COAST GUARD REAUTHORIZATION

The two-year Coast Guard Reauthorization Act passed the House earlier this year and also passed out of the Commerce Committee. Full consideration in the Senate is expected this fall. Commerce Committee priorities for the legislation include new authorities to combat illicit trafficking and maintaining current funding levels for the military branch that patrols and protects our coastline.

CONSUMER PROTECTION

Building on investigative and legislative efforts to enhance protections of consumer rights and safety, the Commerce Committee will continue proactive efforts to identify and address commercial and regulatory failures that create unnecessary and unacceptable public risks.
