Dear Senators Schumer, McConnell, Cantwell, and Cruz:

No one should have sexually explicit images of themselves released online and distributed without consent. With the advancement of artificial intelligence (AI), these images no longer need to be real to cause harm. The rise of AI-generated non-consensual intimate imagery, previously referred to as "deepfakes", is abhorrent and is increasingly harming victims indiscriminately. While popular celebrities like Taylor Swift have been victimized, there are also countless stories of adult victims as well as teenage girls at high schools in your community. While several states have taken action to address this issue, only federal legislation can reign in this growing problem.

That is why we are pleased to see the leadership of Senators Ted Cruz and Amy Klobuchar who have co-authored S. 4569, the TAKE IT DOWN Act.

This bipartisan bill will protect the victims of digital exploitation, hold internet platforms accountable by requiring them to remove such imagery and



provide justice for victims by allowing prosecutors to go after those who publish non-consensual explicit images.

This appropriately-targeted legislation focuses on specific harms. The notice-and-takedown provision of the TAKE IT DOWN Act is incredibly important and differentiates it from similar legislative attempts. Currently, no federal law requires online platforms to remove non-consensual intimate images upon request. Victims have seen time and time again that social media sites are unwilling to prioritize the takedown of such images. The bill corrects this problem and holds Big Tech accountable to prevent the further sharing of such imagery. The distribution of non-consensual intimate images often causes victims significant emotional, psychological, and social distress, anxiety, and depression, which in some cases lead to self-harm.

Protecting victims, providing legal recourse, and holding Big Tech accountable are important reasons to take this issue seriously.

We the undersigned organizations fully support the TAKE IT DOWN Act and call on the Senate Commerce Committee to pass this landmark, bipartisan, and lifesaving legislation now. We urge Senate leadership to swiftly move this legislation to the floor after it passes the Committee.
