In my position as Director (and previously Senior Program Officer and Program officer) for the Journalism and Media program at the MacArthur Foundation, I have spent the past twenty years supporting the institutions and programs of public media (e.g., PBS, NPR, NewsHour, FRONTLINE) and the infrastructure and field around public media (e.g., organizations and programs that support independent producers and nonprofit journalism). Currently I manage a \$25 million a year portfolio of grants, much of it very consistent with the mission of the Corporation for Public Broadcasting. Our goal is to support the creation and dissemination of high-quality news and narrative content that informs, engages and activates Americans to preserve and participate in democratic values and institutions. I am familiar with both the enormous assets of the American public media system and areas where the system can be strengthened. I would like to assist and contribute to CPB strengthening and enlarging the positive influence of PBS, NPR, and local stations in educating Americans about their communities, their nation, and their world; combatting disinformation and polarization; and leading on innovation, collaborations, creativity, and diversity.

I have served on a number of boards where financial and management oversight was an essential part of my duties, and I have worked with and evaluated hundreds of large and small grantee organizations to assess their financial and management
