Stop Sexual Assault in School

reached a turning point in this regard—where we once had to recognize the dangers of images being circulated without consent online alone, our attention must additionally turn to the distribution of manipulated or entirely faked images generated by artificial intelligence (AI). Unfortunately, AI has increasingly made it difficult to discern between a real or a manufactured image, adding to the trauma experienced by victims.

Your bill would protect victims from harassment, intimidation, and exploitation by holding accountable the individuals who publish or intend to publish non-consensual intimate imagery (NCII) as well as requiring websites to remove NCII that have been manipulated or generated by AI. By taking these substantial actions to hold both the individual and medium accountable, the safety and dignity of children and adults can be better safeguarded.
