Given the current mission, major programs, and major operational objectives of the Coast Guard, what in your background or employment experience do you believe affirmatively qualifies you for appointment to the position for which you have been nominated, and why do you wish to serve in that position?

**I have served in a broad range of operational and staff billets over a 30-year active duty commissioned career. These include working operationally across most aspects of port operations, as well as underway aboard a cutter, and as command cadre in the Coast Guard’s deployable specialized**

**forces. I am currently the Commander of the Eighth Coast Guard District, encompassing 26 states in America's Heartland from the Canadian border to the Gulf of Mexico, and the vast majority of the Nation's most economically and strategically important ports. Staff-wise, I completed a successful assignment at the Flag level as the Commander, Personnel Service Center in charge of the Coast Guard's military workforce and recruiting efforts. I have also filled Director-level executive programmatic functions, worked on human resource initiatives, and overseen and implemented the Coast Guard's fiscal year budget. I have served internationally as a Commanding Officer and as the Head of Delegation for the United States at international bodies, as well as externally to the Coast Guard as a Senior Military Fellow, and at industry training in a major port complex. These experiences, conducting operations, leading Coast Guard women and men, and engaging with our Federal, state, local and industry partners as well as our governing bodies at the Department, Administration and Congressional level, have provided me with the foundation to assume this role at the next level of executive leadership.**

**I wish to serve in this position not only to help continue the proud traditions of the Coast Guard that have existed since our Nation's founding, but also to help shape and lead the Service into the future. I love the Coast Guard and feel privileged to serve the Nation and our fellow citizens. I enjoy the Coast Guard's broad authorities, unique roles, culture, and most of all, our amazing work force. The demands on the Coast Guard are ever-increasing, and I am excited to be part of a leadership team that understands the need to continuously learn and improve, while remaining true to our core values.**

23. What do you believe are your responsibilities, if confirmed, to ensure that the Coast Guard has proper management and accounting controls, and what experience do you have in managing a large organization?

**The Coast Guard, as an armed force/military service, a regulator, a law enforcement agency, and an entity that has successfully overseen 11 missions for over 233 years, is a trusted institution. Accountability and transparency are the cornerstone of that trust, and Coast Guard leaders must set the standard for ethics, and be above reproach, avoiding even the appearance of impropriety at all times. If confirmed, it will be my responsibility to hold not only myself, but my subordinates and the entire enterprise to this high standard, and ensure we are good stewards of the**

**resources and trust afforded by our overseers and the American taxpayers. This includes a proactive and responsive leadership role in management, accounting, auditing, inquiries and investigations of all matters associated with the Service, both inside and outside of my direct organization. We are stronger as a Service and an institution when we hold ourselves accountable to the highest ideals and standards.**

**I have served in leadership roles in several large organizations. This includes currently serving as the Commander, Eighth Coast Guard District, and previously serving as the Commander, Personnel Service Center, overseeing all workings of the Coast Guard's 45,000 strong military workforce. I was also assigned as Coast Guard's Director of Inspections and Compliance (5PC), where I led all of the Nation's Prevention activities associated with the safe operation of commercial and recreational vessels and facilities. I also served as the Coast Guard's Acting Director/Deputy Director of Marine Transportation Systems (5PW), where I oversaw all navigation and waterways management functions across the U.S. I also served as the Budget Director/Chief, Office of Budget and Programs (CG-82), overseeing the Service's approximately \$13 billion in annual appropriations.**

**I have had numerous other leadership positions including Acting Sector Commander, Deputy Sector Commander and Prevention Department Head for Sector Jacksonville, Florida, the U.S. Head of Delegation to the International Maritime Organization (IMO) for the Subcommittee on Navigation, Communications and Search and Rescue (NSCR), and Commanding Officer of Coast Guard Activities Europe with an Area of Responsibility covering all of Europe, Africa and the Middle East.**

24. What do you believe to be the top three challenges facing the Coast Guard, and why?

**The Coast Guard faces numerous challenges. Most significant among those:**

**Personnel shortages: Recruiting/Retaining a talented workforce and caring for our families. The Coast Guard is respected and world renowned because of our people and our culture, supported and enabled by our families. The Coast Guard's operational and professional excellence stems from the high caliber of our talented workforce - we must continue to**



**recruit and retain the best and brightest candidates the Nation has to offer; in this effort, we must continually strive to recruit a diverse population that reflects the Nation we serve. As the Service is simultaneously competing with all other military services, institutions and job fields, we must ensure we are an employer of choice, an organization of the highest standards, and a place where all members feel welcome and empowered to reach their highest potential. We must also work to take care of our members and their families, and ensure that their medical, housing, and other resources are world class and deserving of the service and commitment they provide every day.**

**Technology: The Coast Guard must keep pace with the rapidly changing world of technology – this is not merely our internal C5I infrastructure and systems, but crosses into cyber, AI/ML, data, mobility and evolutionary changes such as autonomous vessels and unmanned aircraft systems. The Coast Guard must continue to modernize both operationally and for efficiency - communications, methods of Maritime Domain Awareness, audit, enterprise risk, evaluation, accountability etc. all depend on 21<sup>st</sup> Century IT capabilities. Additionally, the commercial industry and private sector are currently modernizing at a pace much faster than the Coast Guard and the military/Federal government writ large; the way in which we oversee and regulate, interact/conduct business with the public, and receive and provide information must continue to evolve, while we retain the operational excellence, culture, proficiency and professionalism that the Nation expects and deserves.**

**Infrastructure and other Mission Support investment: The Coast Guard must continue to make good decisions with and compete for/justify the resources we receive. Expanding missions on top of traditional demands on the Service, both at home and internationally, require us to invest in our surface, aviation, shore, IT, and human resources portfolio in order to provide the capability to conduct all mission sets, and across all areas of operation. Our aging assets and infrastructure require immediate, significant and ongoing/sustainable investment, as well as a clear future strategy, to meet that demand. This will require us to tell our impressive story and continue to prove our worth by being the world's best Coast Guard.**

**I have no new matters that weren't previously disclosed in my 07 Senate Questionnaire. The matter I previously disclosed is as follows:**

**In October, 1996, when I was a Lieutenant Junior Grade, I was charged with Petty Theft, Battery, and Battery on a Police Officer. The Dade County Court dismissed all charges in January, 1997. In December, 1997, the Court ordered the police record expunged. The charges stemmed from a verbal altercation at a restaurant between my group of friends and another group. Although I was not present when the altercation started, I returned at the same time as police officers employed as restaurant security. An officer saw what he believed to be a bulge in my pocket and reached his hand into my pocket to retrieve it, approaching me from behind. Surprised because he approached me from behind and without knowing he was a police officer working security, I grabbed his wrist and he arrested me. I immediately reported the arrest to my chain of command, which decided to take no action against me. I have reported this incident in every security clearance investigation since the incident.**

**In preparing for this questionnaire, I was notified I was named in an EO complaint of which I was previously unaware. In 2022, while serving as Commander, Personnel Service Center, I was named in a complaint by a Lieutenant who alleged discrimination on the basis of religion when the U.S. Coast Guard denied the member's appeal request for religious accommodation from the U.S. Coast Guard Coronavirus 2019 (COVID-19) vaccination mandate and delayed the member's promotion to Lieutenant Commander because the member had not received the COVID-19 vaccination. I had no supervisory or work relationship with the complainant. I was notified that a Final Agency Decision in July 2023 found the member failed to prove the Coast Guard subjected them to discrimination as claimed.**



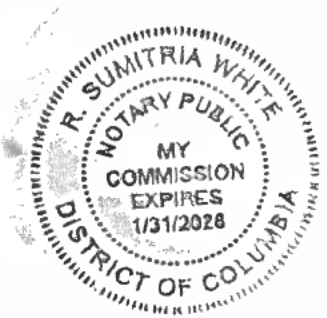

## U.S. Coast Guard

RDML Barata serves as Commander, Eighth Coast Guard District and is responsible for Coast Guard operations spanning 26 states, including the Gulf of Mexico coastline from the Florida panhandle to United States border with Mexico, the adjacent offshore waters and outer continental shelf, and the inland waterways of the Mississippi, Ohio, Missouri, Illinois, and Tennessee River systems.

His previous Flag assignment was as Commander, Coast Guard Personnel Service Center, where he was responsible for executing the Coast Guard's human resource policies by recruiting, accessing, assigning, developing careers, maintaining well-being, compensating, separating, and retiring the nearly 45,000 members of the active duty and reserve military workforces.

RDML Barata's field assignments include Commanding Officer of Activities Europe, as well as tours at Sector Jacksonville, Marine Safety Office Providence, and Marine Safety Office Miami where he served for over 13 years in various capacities conducting marine safety, OCMI/COTP, prevention, and incident response/emergency management missions. RDML Barata also served as the plankowner Executive Officer of Maritime Safety and Security Team Boston (MSST 91110) and as Deck Watch Officer aboard USCGC SENECA (WMEC 906).

RDML Barata's staff assignments include Director, Inspections and Compliance (CG-5PC), Deputy Director, Marine Transportation Systems (CG-5PW), Chief, Office of Budget and Programs (CG-82), AC&I Coordinator and Program Reviewer (CG-821), and Senior Marine Safety/Prevention Assignment Officer at the former CG Personnel Command (CGPC OPM-2).

RDML Barata is a 1993 graduate of the U.S. Coast Guard Academy, New London, CT, where he earned a Bachelor of Science in Management. RDML Barata earned a Master of Arts in National Security and Strategic Studies from the Naval War College in Newport, RI, in 2014 and served as a Senior Military Fellow at the Center for a New American Security (CNAS) in Washington, DC, from 2014-2015.
