I have been a proud member of the U.S. Coast Guard for more than 29 years. During my career I've had the honor to lead Coast Guard women and men in operational missions as well as administrative settings. As I have become more senior, the teams I have led expanded in number of people as well as mission complexity. In addition to an expanding span of control my jobs as the Coast Guard's Senate Liaison Officer and the Chief of Staff to the Atlantic Area Commander afforded me opportunities to exercise strategic leadership and begin laying the groundwork for our future Coast Guard. My operational, administrative and Department of Defense experience combined with geographic diversity and proven positive leadership affirmatively qualifies me for appointment to which I have been nominated.

21. What do you believe are your responsibilities, if confirmed, to ensure that the department/agency has proper management and accounting controls, and what experience do you have in managing a large organization?

It is imperative for the U.S. Coast Guard to ensure our service has and maintains proper management and accounting controls. Validity and accuracy of the Service's financial statements are essential to building trust with our own service, trust with the American taxpayers and trust and confidence with our oversight committees. If confirmed, I would draw upon my degrees in management and business and my years of as a fund manager and Senate Liaison for the Coast Guard. As a leader in the Coast Guard it will be a priority for me to instill the need to manage our funds wisely from

our most junior member to our most senior member and meticulously track and account for how the funding utilized.

- 22. What do you believe to be the top three challenges facing the department/agency, and why?
 - A. The US Coast Guard has been deferring maintenance for shore infrastructure for an extended period of time, decades in some instances. This has led to backlogs of more than \$2.6 Billion on approximately 5,600 individual projects. As a result of these backlogs some Coast Guard members have had to do their jobs in less than ideal conditions and some Coast Guard families living in Coast Guard housing have faced disruptions in their daily life. During a time while the Coast Guard is fielding new state of the art capital assets and building a cyber-capability, the service will be hard pressed to allocate sufficient shore infrastructure funding to noticeably decrease the backlog.
 - B. The US Coast Guard has been diligent in acquiring new operational surface assets, from small boats to National Security Cutters. This diligence has resulted in the Coast Guard decommissioning 20, 30, and more than 40 year old vessels. The older vessels are being replaced by highly technical and more capable vessels. Viewing this from an operational perspective, it is a great benefit for the Coast Guard. However; viewing this from an infrastructure perspective this is an enormous challenge. It is not possible to simply decommission one cutter and replace it with a new cutter in the same homeport at the same pier. The newer cutters are longer with more gross tonnage than the decommissioned cutters and the electrical loads are also much greater for the new state of the art cutters. In addition, in some cases it will become necessary for the Coast Guard to acquire additional property in an existing homeport or build out a homeport that is new to the Coast Guard. As a result, the Coast Guard is tackling a nationwide, capital intensive, multivariable challenge that will likely span decades.
 - C. The Coast Guard is relatively new to the Cyber mission. It will be an enormous challenge for the service to fully build, train and equip our Cyber work force and define what the Coast Guard's role is as part of the Federal Government's overall cyber mission. The Coast Guard's role in cyber is only going to increase and in an era of rapidly advancing technology, the importance of fielding the newest cyber assets and capabilities, in an effort to stay ahead of the adversaries will be a very difficult challenge for the service.
