8	Natives and possesses personal knowledge of, and di-
9	rect experience with, subsistence uses and shall be
10	nominated by the Board and appointed by the Sec-
11	retary."; and
12	(E) by adding at the end the following:
13	"Board members appointed under subpara-
14	graphs (N) and (O) shall serve for 3-year
15	terms, and may be reappointed once."; and
16	(2) in paragraph (4)(B), by striking "Not more
17	than 15 percent of the funds provided to the Sec-
18	retary of Commerce under paragraph (1) may be
19	used to provide support for the Board and admin-
20	ister grants under this subsection." and inserting
21	"The funds provided to the Secretary of Commerce
22	under paragraph (1) may be used to provide support
23	for the Board and administer grants under this sub-
24	section. The Board shall maximize the percentage of

1 quality standards in administering grants under this 2 subsection. On the date that is 5 years after the 3 date of enactment of the North Pacific Research 4 Board Enhancement Act, not more than 15 percent of the funds provided to the Secretary of Commerce 5 6 under paragraph (1) may be used to provide support 7 for the Board and administer grants under this sub-8 section.".
