3 (a) ADDITIONAL "RIP AND REPLACE" FUNDING.—

4 (1) INCREASE IN EXPENDITURE LIMIT.— Sec-
5 tion 4(k) of the Secure and Trusted Communica-
6 tions Networks Act of 2019 (47 U.S.C. 1603(k)) is
7 amended by striking "\$1,900,000,000" and insert-
8 ing "\$4,980,000,000".

1 (2) APPROPRIATION OF FUNDS.—There is ap-
2 propriated to the Federal Communications Commis-
3 sion for fiscal year 2024, out of amounts in the
4 Treasury not otherwise appropriated,
5 \$3,080,000,000, to remain available until expended,
6 to carry out section 4 of the Secure and Trusted
7 Communications Networks Act of 2019 (47 U.S.C.
8 1603).

9 (b) SPECTRUM REAUTION.—

10 (1) FCC AUCTION 97 REAUTION OF CERTAIN
11 LICENSES.—Not later than 1 year after the date of
12 enactment of this Act, the Federal Communications
13 Commission shall initiate a system of competitive
14 bidding under section 309(j) of the Communications
15 Act of 1934 (47 U.S.C. 309(j)) to grant licenses for
16 spectrum in the inventory of the Commission within
17 the bands of frequencies referred to by the Commis-
18 sion as the “AWS-3 bands”, without regard to
19 whether the authority of the Commission under
20 paragraph (11) of that section has expired.

21 (2) COMPLETION OF REAUTION.—The Federal
22 Communications Commission shall complete the sys-
23 tem of competitive bidding described in subsection
24 (a), including receiving payments, processing appli-
25 cations, and granting licenses, without regard to

1 whether the authority of the Commission under
2 paragraph (11) of section 309(j) of the Communica-
3 tions Act of 1934 (47 U.S.C. 309(j)) has expired.
